



SHOOT THE ARCHITECT 2014 COMPETITION TERMS & CONDITIONS OF ENTRY

1. Information on how to enter forms part of these terms and conditions.
2. This is a competition of skill and chance plays no part in determining the winners.
3. The competition closes at 5.00pm Central Australia time on 9 October 2014.
4. Entry into the competition is deemed by acceptance of these terms and conditions.
5. Herewith, Shoot the Architect will be referred to as the Promoter. The Promoter is The Australian Institute of Architects South Australian Chapter.

Eligibility Criteria:

6. Entry is open to all professional and amateur photographers.
7. Submitted artworks must include a South Australian registered Architect.
8. Submitted artworks must be solely the original work of the entrant.
9. Copyright of submitted images will remain with the photographer. By submitting to this competition, the photographer grants the Promoter the consent to use the submitted photograph/s to promote this competition only and for subsequent media releases pertaining to public relations in direct relation to this competition only. Images will not be transferred to any other third party organisation without prior consultation between the Promoter and the photographer.
10. The Promoter reserves the right to request proof of identity, residency, employment and professional status. In the event that an entrant cannot provide satisfactory proof, the Promoter may, in its absolute discretion, disqualify the entrant.
11. By entering this competition, you warrant that the submitted artworks do not and will not in the future infringe the rights, including intellectual property rights, of a third party. You indemnify the Promoter and its related bodies corporate in respect of any breach of the foregoing warranty.
12. By entering this competition, you warrant all necessary waivers, consents and releases pertaining to each individually submitted artwork have been secured. You indemnify the Promoter and its related bodies corporate in respect of any breach of the foregoing warranty. Winning entrants may be required to provide evidence of any or all required waivers, consents and releases relating to any submitted artwork.
13. Entrants must not submit any artwork that:
 - a. includes a person or persons unless you have their consent
 - b. is defamatory, obscene, pornographic, vulgar, or otherwise unlawful
 - c. contains a nude or semi-nude person aged 16 years or under
 - d. contains excessively violent or sexual content
14. The Promoter shall have sole discretion to accept or reject any submitted artwork in consideration of the requirements of the above items 10, 11 and 12.

Judging:

15. Each entry will be individually judged based on creative and artistic merit by a panel of judges appointed by the Promoter. Winning entries will demonstrate originality of thought and technical excellence. Each entry will remain anonymous for the judging process. 2014 Judges are to be advised.
16. The Promoter reserves the right to make changes to the judging panel at any time for any reason whatsoever.
17. The judges' decisions will be final and no correspondence will be entered into.

18. Judging will take place on or before 13 October 2014.
19. Entrants whose submitted artworks are chosen as finalists will be contacted by 10 October 2014.

Entry:

20. All entries must be submitted via the online form at www.fad.org.au
ABSOLUTELY NO ALTERNATIVE METHOD OF ENTRY WILL BE ACCEPTED.
21. The Promoter is not responsible for lost or interrupted communications or unavailable network server or other connections, failed telephone or computer transmissions or other errors of any kind, whether human, mechanical or electronic whether misedelivery, before or after transmission. The Promoter assumes no responsibility for any error, defect, delay, theft or unauthorised access to or alteration of entries.
22. Entrants may submit a colour or black and white submitted artwork. The submitted artwork must be a jpeg file with a minimum size of 1MB and a maximum of 3MB at 300dpi. Submitted artworks not meeting this requirement will not be accepted.
23. Each eligible entrant may submit up to three (3) artworks only. The entry fee of AU\$35.00 is payable per submitted artwork; i.e. three submitted artworks will require a fee of AU\$105.00.
24. The entrant should ensure that all submitted artworks are uploaded as they are meant to be viewed with no rotation required. Portrait and landscape submitted artworks are acceptable.
25. Digital manipulation of submitted artworks is permissible.
26. Entrants are required to retain a copy of the submitted artwork submitted in the highest resolution possible.
27. Should an entrant's contact details change during the competition period, it is the entrant's responsibility to notify the Promoter.

Finalists:

28. Entrants who qualify as finalists after judging will be notified by 10 October 2014.
29. Winners and finalists will be invited to the FAD closing night on 14 October 2014 where winners will be announced.
